- (b) The Club shall pay the Judge a sum of **Rs.25,000/- per day of judging as judging fees.** The judging fee of Rs.25,000/- per day must be paid on arrival, before the show commences. It would be the duty of the Judge to sign a receipt for the judging fee received and he/she shall not make any other claims.
- (c) The Judges shall also be paid their Travel expenses (Taxi expenses) from their Residence to Airport and similarly from the Airport to their residence on their return. Hence an amount of Rs.3000/- over and above the judging fees shall be paid to the judges in this respect.
- (d) The Judges shall not judge **more than 200 dogs on a day** and in the event of the catalogue entries being above 200 dogs, the respective club secretary could opt to invite a second judge or the Club has the option to decide that the same judge could continue to judge more than 200 dogs **subject to the judge's confirmation and acceptance. In such an event** the judge should then be compensated by paying an extra judging fee of Rs.25,000/. **A maximum of 275 dogs (with extra judging fee) could be judged by a judge on a single day.** Should the number of dogs exceed 275 in number then the additional dogs would necessarily have to be judged on a **second day** and the judge compensated accordingly or a second judge could be invited to judge the balance number of dogs.
- (e) The judging fee for a specialty show will beRs.15,000/-per specialty show.
- (f) The judging fee for an Obedience show is Rs. 25,000/- per show.

The judge hereby gives an undertaking that he/she will not judge more than 04 pointed shows overall in a show season and shall not judge more than one pointed show in a zone in a show season.

- 3. Further in relation to air fares provided by the Club, the Judge **shall not accept any judging assignment** en-route to or from this assignment without the written consent of the inviting club.
- 4. Once the Judge has accepted to judge and has executed the Judge's contract, it shall be the duty of the inviting club to send the air ticket at their earliest. In case of any cancellation of the judging assignment by virtue of the Judge being unable to undertake the assignment owing to unavoidable circumstances, it shall be the duty of the Judge to inform the club of his / her inability to come the moment it has been confirmed that he / she will not be able to fulfill the assignment owing to unavoidable and compelling reasons. If he / she fails to do so the club must be compensated for any travel expenses they may have already incurred.
- 5. No Judge shall **cancel or withdraw** from their judging assignment at the last minute in order to accept another judging assignment either in India or overseas unless he / she has been released by the inviting club and such release is obtained in writing from the judge.
- 6. **No Club shall terminate a Judge's contract** in order to accommodate some other Judge either from India or overseas unless the club has obtained the written consent of the Judge already contracted.
- 7. After signing the contract, the club will be permitted to re-allocate the breed, group allocated to the judge only with the **mutual consent** of the club and the Judge.
- 8. In case of any untoward incident of a dog biting the judge while judging, the club shall bear the expenses of the entire medical treatment the judge would have to undergo post the bite.

- 9. It is the duty of the club to arrange for pickup and drop of the judge to and from the airport of arrival and the hotel where the judge's accommodation has been arranged. The judge should necessarily be accompanied by a responsible committee member assigned by the club.
- 10. The safety and security of the judge while being hosted by the inviting club is the responsibility of the club and the club should ensure the same.

As an acknowledgement of the acceptance of the terms and conditions, the Judge is required to sign, date and return the duplicate copies of this judge's contract within 15 days from the date of receipt.
